### Event Philosophy:

**The event that everyone wants to see!** Billed as a replica of the Journeymen Fall Classic-HS Tournament, arguably one of the toughest preseason competitions in the country! The Journeymen Classic – OverFLO features the best of four additional segments within our wrestling community: Elementary, Middle School, OverFLO Challenge and our new female division.

**MIDDLE SCHOOL:** The best of the best middle (6th-8th graders), from across the USA squaring off in a preseason round-robin format.

### OVER-FLO EVENT PHILOSOPHY:

**OVER-FLO CHALLENGE:** Didn't make the cut in the Journeymen Fall Classic-HS due to being lighter criteria? Don't stress. You can work your way into the event by wrestling in this mini tournament. Winners of their respective weight/bracket earn a slot in Sunday's competition. Winners must weigh in again for Sunday's competition. There will be a five-pound allowance, and qualifying wrestlers can weigh in directly after competition on Saturday.

**Best of the Best:** This is a true battleground for the hardcore wrestlers. Traditionally bracketed or modified round-robin – whatever can accommodate more or if needed. These brackets will be peppered with decorated and accomplished opponents. State Qualifiers or better get preference. If there are 4-8 wrestlers in a weight, we will form a modified round-robin bracket, anything other will be traditional bracketing.

\*FYI - Eight-man round-robins are two four-man groups with a cross-over.

### How do I participate?

**Tentative weights:** 70, 75, 80, 85, 90, 95, 100, 105, 112, 120, 128, 136

\*DOUBLE MIDDLE SCHOOL HOLD BACKS SHOULD COMPETE IN THE OVER-FLO DIVISION

**OVERFLO CHALLENGE:** • 9th-12th grade • NFHS Rules • Folkstyle • Bout Length: 2:00, 1:30, 1:30 periods • College out of bounds in effect

**Tentative weights:** 106, 113, 120, 125, 130, 135, 140, 145, 152, 160, 170, 182, 195 & 225

If certain weights do not get completely filled, we reserve the right to either consolidate or completely dissolve the weight and forego the weight class all together.

Once you've been accepted at a particular weight, you are expected to compete at that weight since these are all pre-determined brackets. Therefore, select the appropriate weight from the start! That said, you will have approximately 15 days out from the event to change your weight.

\* If you need to change your weight after the 15 day "prior period", you can request consideration via email. There's a \$40 "weight change" fee assessed if the change is accommodated.

If you have paid an entry fee for the OverFLO and qualify for Sunday's main event, you do not have to pay an entry fee again.

### Registration & Entry Fee:

- All entry forms must be completed online and meet November 15, 2020 deadline or before the event is sold out. Maximum competitors is 350.
- Once you've received a written pre-approval and a four digit code from Journeymen Wrestling to wrestle in the event, you'll be directed to register online via [www.journeymenwrestling.com](http://www.journeymenwrestling.com).
- Once you've been approved, you are expected to have finished the registration at that moment (register and pay), otherwise the entire process starts over and eligibility is reassessed. Please reach out only when you're ready to actually enroll
- Registration is \$65 • THERE ARE ABSOLUTELY NO REFUNDS ONCE YOU REGISTER
- Spectator Fee: \$20 (Pertains to Saturday only, not the main event HS division on Sunday)
- Coach's Pass/Fee: \$50 (good for both days, Nov. 21 & 22, 2020)
